THE BASIC SKILLS COURSE REQUIREMENT

Newly admitted attorneys must attend a Basic Skills Course within one year of admission to the Illinois bar. If you have completed a Basic Skills Course, you are one step closer to fulfilling the Basic Skills Course Requirement, but you're not done yet.

HOW DO I CERTIFY MY COMPLIANCE WITH THE BASIC SKILLS COURSE REQUIREMENT?

Obtaining and retaining your Basic Skills Course Certificate of Attendance issued by the course provider does not fulfill the Basic Skills Course Requirement. A Certification Form will be mailed to you from the MCLE Board before the end of the 12-month period following your admission to the Illinois bar. To fulfill the Basic Skills Course requirement, you must complete and return this Certification Form to the MCLE Board by the due date stated on the form. A sample of the Certification Form that you will receive can be found on the second page of this notice.

WHAT IF I DON'T RECEIVE A CERTIFICATION FORM FROM THE MCLE BOARD?

The Certification Form will be mailed to your address of record on file with the Attorney Registration and Disciplinary Commission ("ARDC"). If you don't receive this form by the end of the 12-month period following your admission to the Illinois bar, contact the MCLE Board for a copy. Failure to receive a Certification Form is not an excuse for failure to file your certification. Certain late fees and removal from the Master Roll of Attorneys can be assessed for failure to file your Certification Form.

WHAT DO I DO ONCE I FULFILLED MY BASIC SKILLS COURSE REQUIREMENTS?

Illinois attorneys are required to complete CLE hours for each reporting period as outlined below, unless they are eligible for an exemption. However, **you may not begin earning general MCLE credit until the 12-month period in which to satisfy the Basic Skills Course requirement ends.**

First Letter of Last Name on Date Admitted to IL Bar	24 Hour Reporting Period	30 Hour Reporting Periods
A through M	July 1, 2008 to June 30, 2010	Two-Year Period Beginning July 1 to June 30 of Each Subsequent Even Numbered Year
N through Z	July 1, 2009 to June 30, 2011	Two-Year Period Beginning July 1 to June 30 of Each Subsequent Odd Numbered Year

The MCLE credit hours earned during each reporting period must include at least four credit hours toward the professional responsibility requirement. For more information about the professional responsibility requirement, refer to Illinois Supreme Court Rule 794(d).
