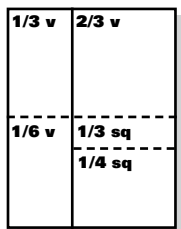
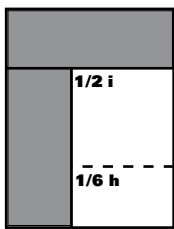
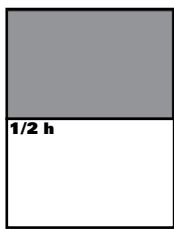

Trim Size 8½"x11"	Width	Depth
Full Page (Live Area)	7-1/4"	10"
Full Page (Bleed)	8-3/4"	11-1/4"
Spread (Live Area)	15-3/4"	10"
Spread (Bleed)	17-1/2"	11-1/4"
2/3 Page Vertical	4-3/4"	9-1/4"
1/2 Page Island	4-3/4"	7-1/8"
1/2 Page Horizontal	7-1/4"	4-5/8"
1/4 Page	4-3/4"	3-5/16"
1/3 Page Vertical	2-1/4"	9-1/4"
1/3 Page Square	4-3/4"	4-3/4"
1/6 Page Vertical	2-1/4"	4-5/8"
1/6 Page Horizontal	4-3/4"	2-1/4"

Keep live matter 3/8" from trim and 3/8" from gutter on non-bleed ads.
 Allow at least 1/8" beyond trim (on all sides) for bleed ads.

Printing Specifications

Submitting Material

Include all elements with the job. Include all source documents (QuarkXPress, InDesign, PageMaker), fonts, high resolution graphics (Adobe Photoshop, Adobe Illustrator, or Freehand files). Submitting PDF files offer several advantages. PDFs that are created properly by embedding fonts and converting all art to CMYK instead of RGB reduce or eliminate delays.

Fonts: Make sure to include both the Screen and Printer fonts. We suggest you use Type 1 PostScript fonts since the TrueType may cause problems during prepress file processing.

Documents: Build your pages to trim size. Include an 1/8" bleed for elements that extend off the page and use 1/4" for type safety inside the page. Do not use the pre-defined "hairline" rule width. We recommend using a minimum rules width of .25 points.

Illustrations: To avoid potential font problems, convert your type to "Outlines" in Illustrator or "Paths" in Freehand. Don't forget to submit your Freehand and/or Illustrator files.

Photoshop: Make sure your Photoshop files are 300 dpi and either CMYK or grayscale. Do not scale your photoshop files over 130% (in QuarkXPress, InDesign or PageMaker). **Do not submit RGB files.**
